To reserve a place for your student: Return this Re-Enrollment Form and your non-refundable Re-Enrollment Fee (\$225.00 per student – maximum \$450.00 per family) to the school office by February 29, 2008. **After this date, Enrollment is open to the community. Your Re-Enrollment Form will not be processed nor a seat reserved for your child until your re-enrollment Fee is received. Additionally, the re-enrollment fee will increase to \$250.00 per student – maximum \$500.00 per family, after February 29, 2008.**

Those paying tuition annually will receive a 3% discount if payment is received prior to July 1, 2008.

Part IV. Parent/Guardian Financial Commitment

I agree to read and abide by the purpose and policies of Statesville Christian School as delineated in the applicable parent/student handbook and do hereby request that my child be accepted as a student.

In consideration of Statesville Christian School accepting my child as a student, I will accept full financial responsibility for my child's tuition, fees, and costs assessed for damage to books or school property. It is understood that failure to pay all tuition and fees in a timely manner may result in dismissal and the withholding of grades and transcripts until all financial obligations have been met. Students of parents whose account is in arrears more than sixty days will not be permitted to attend class until the account is made current or arrangements are made in writing with the Business Office to bring the account current. **Students with a past due balance will not be permitted to re-enroll until the account is made current.** Students are enrolled for the entire year; therefore, teacher contracts and budgets are set on this basis.

A student withdrawing prior to September 1st will be charged three months tuition unless the school receives written notification **prior to** June 1st. After September 1st, a student will be charged for all tuition due plus tuition for an additional 30 school days. Report cards and records will not be released with any outstanding balance, including the withdrawal fee remaining at SCS.
