Note 1: An alternate Tuition Schedule applies to students participating in the SCS Learning Development Centers. This Schedule is provided to parents on an as-needed basis.

Note 2: An alternate Tuition Schedule applies to international students. This Schedule is provided upon request.

Pay by June 1st and take advantage of a two and a half percent (2.5%) discount off your tuition (the \$200 curriculum/tech fee is excluded from this discount).

NEW STUDENT ENROLLMENT:

A non-refundable application fee of \$125.00 for each student is due with the admission application. Upon acceptance to SCS, there is a non-refundable enrollment fee of \$500.00 per student (maximum of \$1,000.00 per family). The school will apply half of your enrollment fee toward your first month's tuition.

RETURNING STUDENT RE-ENROLLMENT:

A non-refundable re-enrollment fee of \$500 per student, with a family maximum of \$1,000 is due during the annual re-enrollment period for each returning student. If the re-enrollment form and fee are received on or before February 10, 2012, the school will apply half (\$250 per student or \$500 family maximum) of the re-enrollment fee toward the first month's tuition. Returning students re-enrolling after the close of the re-enrollment period will **not** receive the benefit of having a portion of the re-enrollment fee applied to tuition.

THE FOLLOWING APPLIES TO BOTH ENROLLMENT AND RE-ENROLLMENT:

A **multi-child tuition discount** is available as follows: 3 children, 2 ½% off family total; 4 or more children, 5% off family total.

Payments may be made annually, bi-annually, or divided over 11 months. Monthly payments will start in June. No tuition payment in February 2012 because this is the month for re-enrollment.

Students are enrolled for the entire year; therefore, teacher contracts and budgets are set on this basis. A student withdrawing prior to September 1st will be charged three months tuition unless the school receives written notification **prior to June 1st**. After September 1st, a student will be charged for all tuition due plus tuition for an additional 30 school days. Report cards and records will not be released with any outstanding balance, including the withdrawal fee remaining at SCS.

If **Tuition Assistance** is needed, you may apply only **AFTER** your child has completed the enrollment process. SCS uses the results from an outside agency to determine the level of tuition assistance awarded. Applications for tuition assistance may be secured from the school's business office. Due to limited funds, parents are encouraged to complete the Tuition Assistance Application, with verifying information, prior to mid-March.
